Employee Mandatory Health Screenings

All employees and spouses who are covered under Dunwoody health insurance are required to complete a health screening each year. The health screening(s) must be completed by Monday, December 4, 2023. A penalty of \$25 per pay period for employee or \$50 per pay period for employee and covered spouse for the year of 2024 will be incurred if the health screening(s) is not completed by December 4th.
