## **HOUSEKEEPING SERVICES**

<u>Christmas Day and Week of December 25<sup>th</sup> -- 29<sup>th</sup></u>: Monday, December 25<sup>th</sup>, housekeeping is off. Monday residents will not receive housekeeping services but will receive linens on Tuesday. Tuesday through Friday – residents will receive regularly scheduled housekeeping services.

<u>New Year's Day and Week of January 1 -- 5</u>: Housekeeping is off on Monday, January 1<sup>st</sup>, but Monday residents will receive housekeeping services on Tuesday. Tuesday residents will not receive service but will receive linens. On Wednesday, Thursday, and Friday, residents will receive regularly scheduled housekeeping services.

## SPA

The spa will be open for regular hours effective Friday, December 22<sup>nd</sup>.

## COVID-19

Currently 7 Residential and 12 Care Center residents tested positive and are on quarantine. Two staff members are positive and at home on isolation. Health and Wellness will not be testing residents who have been in contact with COVID positive residents or doing screening covid swabs for residents prior to holiday gatherings. Please have a supply of personal test kits on hand in your unit for use. They are available at CVS, Rite Aid or free when ordering through <u>www.covid.gov</u>. Health and Wellness will only be swabbing symptomatic residents who will have to quarantine until the results of a full respiratory panel returns from the lab.
