Dear Residents, Families and Staff:

We have purchased three AEDs (automated external defibrillators) for usage at Dunwoody Village. They have been placed in three locations:

- Hanging to the right of the elevator in the main lobby
- Hanging to the right of the reception desk in the Care Center Lobby
- Health and Wellness Nurse Responder Bag (for emergencies throughout the campus)

For those who do not want to receive CPR, or do not want an AED used if medically appropriate, please purchase a DNR (DO NOT RESUSCITATE) bracelet from the Dunwoody Village Gift Shop. Licensed nursing staff are aware to look for these bracelets should an event occur. If you are found by a stranger or are off campus, there is no guarantee the bracelet will be noticed. Should you be the first person to arrive on scene to an unresponsive person, please call 911 or instruct another nearby person to call 911 and retrieve the closest AED. If possible, ask someone to activate the closest emergency button, activate your pendant, or call the front desk with the location of the emergency. If you choose to begin CPR and use the AED, turn the unit on and simply follow the prompts. Thank you for your attention to this important matter.

Dunwoody at Home

Earlier today, letters were sent to all Dunwoody at Home (DaH) employees and all Dunwoody Village residents. Below please find key points from those letters:

- There is a temporary transition of the Dunwoody at Home administration to Dunwoody Village and Premier Companion Care Services while we await re-licensure.
- DaH services and staff will remain the same for our residents.
- Hourly rates and fees will remain the same for our residents.
- Billing for residents residing in Independent Living, or using a Long-Term Care Policy, will temporarily change to Premier Companion Care Services.
- DaH employees will temporarily be employed by Dunwoody Village or Premier Companion Care Services.
- Employee rates, benefits, job duties, reporting relationships and hours will remain the same.
