Dear Residents, Families & Staff:

We have had questions about the current recommendations regarding COVID-19 vaccination. Dr. Lawrence has advised that adults 65 years and older receive an additional updated 2023-2024 COVID-19 vaccination. The CDC recommends this booster take place 4 months after your last dose. We held a COVID clinic at Dunwoody in September of 2023. We are working with Phoebe Pharmacy on setting up another clinic date in April and will communicate that date as soon as it is finalized. As always, you can receive an updated vaccine at any outside pharmacy, but we ask that you notify Health and Wellness so your records can be updated. Acute COVID infection protects a person from getting COVID again for about three months. If you have had COVID within the last months, please consult with your PCP as to the optimum time for you to receive another dose. Currently 1 Residential and 2 Care Center residents tested positive and are on quarantine. Two staff members are positive and at home on isolation.

Pool

The pool will be closed on Wednesday, March 27th and Friday March 29th. The pool will be open on Thursday March 28th and the aquatics class normally held on Wednesdays will be held on Thursday. Thank you for your understanding as we make this one-time adaptation to next week's schedule.

First Quarter Facility Cleaning Day 2024

There will be no Residential Housekeeping services on Friday April 5th. All housekeeping personnel will be working to provide a heavy cleaning to many of the common areas and elevators. Residents who are scheduled to receive housekeeping services on Friday April 15th will receive their linens on Thursday April 4th just as if it were a holiday schedule. Thank you for your support in allowing our EVS Department to implement these quarterly cleaning days to help maintain our facility and your home.

Easter Brunch

On Sunday, March 31st, we will serve Easter Brunch in our Auditorium. Seating times are 11:30 a.m. and 12:30 p.m. Brunch will conclude at 1:30 pm. Reservations are required and opened. Reservations can be made for IL residents by going to your Full Count module on Touchtown. Instructions are included under the Dining Services module. Care Center residents and families can make reservations by calling Dining at 610-359-4433. Guidelines for Reservations:

- Maximum party size is 6, which includes residents and guests.
- Resident Holiday Brunch is 22 points. Points cannot be used for guests during holidays.
- Cost for guests is \$25 for each adult; \$15 for child 10-12 years of age, and \$10 for child under the age of 10.
- Parties larger than 6 people cannot be accommodated.
- Double reservations or parties of over 6 people will not be honored.

Pickup for residents will be available for Easter Brunch starting at 11:00am-12:00pm in Hearthside. Delivery will be available for residents who are on our delivery list. A \$5 delivery charge will be attached.
